MEETING WAS CALLED TO ORDER BY DAVID SPINDLE, CHAIRMAN AT 4:01 P.M.

- I. REVIEW AND CONSIDER APPROVAL OF THE REGULAR CALLED MEETING MINUTES HELD NOVEMBER 13, 2018, AND THE SPECIAL CALLED MEETING MINUTES HELD NOVEMBER 29, 2018: Reviewed by members. Jared Johnson motioned to approve the regular called meeting minutes and the special called meeting minutes as submitted by staff. Brett Evans seconded. Motion was unanimously approved.
